Some updates:

- The bid for the re-use of the former Mapleview Nursing Home was withdrawn by the Boyds. We apologize to anyone who did not see the cancellation notice for their presentation, but their withdrawal came too late to stop the announcement in last month's *Tracks*. We plan to rebid the property with only a few small modifications to the bid package, but with a longer time horizon for responses. We know of at least two residents who have expressed interest and we had a number of attendees to the site visit, so we are still hopeful that the property can be brought back to usefulness and the tax rolls. If you can think of anyone who might be interested, please let them know or let us know and we will be glad to follow up.
- Thanks to Ed Bond for fixing up an access ramp and better lighting in the rear of the Town Hall. Selectman Shaun Lennon is negotiating with Taconic Voc-Tech to have students fabricate railings for the ramp and for our utility room.
- Steve Nelson gave us an update on high speed internet access for the Town. Mass Broadband is committed to having our Town Hall connected by mid-2013 and Wired West – the consortium we joined - will be working to bring the “last mile” of access to everyone as soon as possible after that.
- The MA Department of Energy (DOER) denied our request for a change of scope to our original EECB Grant which means that any new energy efficient doors or windows at the Town Hall would require using our own funds or finding other grant money from, e.g. the Green Communities program when and if we get certified. We are taking another look at using the remaining EECBG funds for spray insulation/stucco over the Town Hall's bricks instead of rigid insulation/siding to see if we can get a bid within the funding amount.
- Thanks to Rose Borgnis for revitalizing the Council on Aging with a well-attended kick-off brunch on November 16. We expect that additional events will be forthcoming. Carol and Frank Kennedy have volunteered for the COA; anyone else interested please contact Rose or the Select Board.
- The dialog with CSX continues, now at least at a higher level thanks to the help from State Senator Downing's office. The good news is that Upper Valley Road has been dry so we have not yet needed to resort to filing suit, but we have told the railroad that we expect some positive and long-term response to protect our homeowners.

We hope everyone had a wonderful Thanksgiving. As a Town we have a lot to be thankful for: the natural beauty of our physical environment, certainly, but more so the incredible amount of volunteer effort that goes into making Washington work for all of us. Best wishes to all for a safe and healthy holiday season.

A light lunch will be offered featuring several homemade soups, chili and sandwiches.

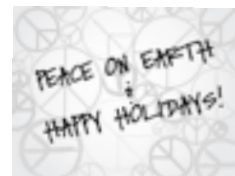
The Straw Draw will be fun for the whole family. Come one, come all—it's the one bazaar that you do not want to miss!
